Temporary Closure of part of Footpath CH 33/52

TAKE NOTICE that in pursuance of Section 14(1) of the Road Traffic Regulations Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, the County Council of Somerset propose to make an Order prohibiting all traffic from proceeding along part of Footpath CH 33/52 from a point 480 metres north of Station Road and running in a north north easterly direction for 220 metres due to the likelihood of danger to the public whilst development works are taking place.

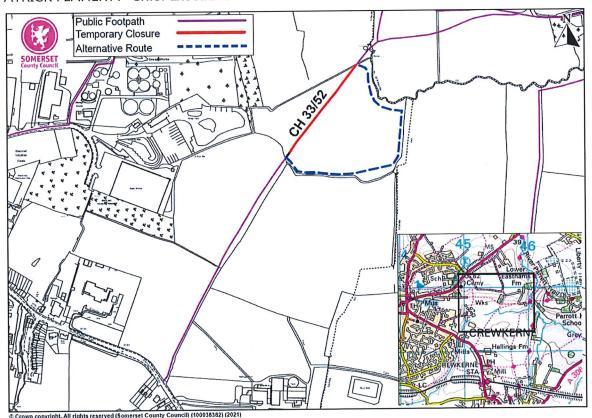
The Order will become effective on 30 October 2021 and will remain in force for six months.
