## **Mayors Annual Budget Report**



The Council has now set the budget for the year 2017/18. During this process a full review of all aspects of its spending was carried out with the aim to achieve the continued provision of services and properly maintained amenities for the town whilst trying to keep any increase to a minimum. As always this was a difficult task as we face fewer services being provided by County and District Councils.

After reviewing general expenses Councillors agreed to maintain funding in the areas that we already support, plus the acceptance of certain increases such as salaries and employer costs due to increased service provision. For energy and other bought in commodities where increases in costs were outside the Council's control, a firm commitment is made to test the market to try and achieve cost effective purchasing of those items.

Further considerations were made and approved that have increased the budget:

- The Victoria Hall structure is in need of considerable work over the coming years. Whilst some works have been carried out over this year many more jobs remain.
- The roof of the Aqua Centre, whilst not being replaced, still has issues due either to a defective membrane or untried building techniques, but means the roof must have more remedial works carried out.

- Owing to poor building work carried out by building companies, now bankrupt, we have been left with outstanding repairs to the George Reynolds Centre, whilst in themselves minor, they nevertheless add to our buildings maintenance costs.
- We are continuing our projects to improve the green spaces and play areas within the town and these new pieces of play equipment are not cheap, but are deemed wanted by the children and parents alike!

With these additions the final budget for the year 2017/18 stands at £439,185 an increase of 28.6% on the current year. Once the adjustment has been made by the District Council for those claiming Council Tax benefit this represents an increase of £46.01 per household or 88p per week.

A major part of this is the Allocation of Government Grant which has reduced from £25,020 to £8,380 (monies granted to offset housing benefit council tax payments), which in itself accounts for a percentage increase of 17% of our precept increase. These are monies devolved from government to offset council tax contributions for those on housing benefits.

This is a considerable increase, one this council has avoided making for many years, but we are unable to prevent this and maintain the standards we have set, and you have come to expect.

## **On and Around Henhayes**

#### Henhayes Playground

The extension to the playground at Henhayes continues to take shape. The whole area was grass seeded some months ago and now that the grass has properly taken, the heras fencing is to be removed and the area opened up to the public. The swings for the two new major pieces of play equipment will shortly be installed. A new flower border has been created and, as soon as the risk of frost has passed, this area will be planted up.

The Council is planning to purchase seats and benches for this new area. Should you wish to sponsor a seat, please contact the Town Council for further information.

Looking ahead, work is underway to choose an appropriate piece of play equipment to be positioned inside the dry "moat" area.

## **Drainage at Henhayes**

An ongoing issue whenever there is heavy rainfall, is the poor drainage of surface rainwater across the lower part of the Henhayes pitch area. The Town Council is therefore working with a drainage contractor to investigate possible improvements to the drainage in this area. Any disruption caused by the necessary drainage improvement groundworks will be kept to an absolute minimum.

## **Please Park Responsibly**





In a town in Germany they have a sign that says, "Are you stuck in traffic? If so, the problem is you!" We may not be quite so forthright in Somerset, but it is a fact that many of the traffic problems in the town are caused by inconsiderate or thoughtless parking. Please drive and park with consideration for other road (and pavement) users.



**Blue Badge Holders** - There are government rules on where blue badge holders may park and where they cannot park. A blue badge is not a licence to park anywhere. Please do not park at a bus stop during hours of operation or on the zig-zag lines at pedestrian crossings.

DO NOT park where it would endanger, inconvenience or obstruct pedestrians or other road users, e.g. opposite or within 10 metres of a junction, where it would hold up traffic and where it would make the road narrow such as a traffic island. Finally the rules state; 'if you park where it would cause an obstruction or danger to other road users you could be fined or receive a penalty charge notice or have your vehicle removed'.

## Are you a Dog Owner?

Did you know that if your dog injures a person, another animal or destroys property, you may be liable for damages?



Successful claims can be brought against dog owners who can be proven legally liable for the injury, illness or death of a third party occurring as a result of an incident in which the animal is involved. Without third party liability insurance dog owners may find themselves paying compensation and costs awarded against them or a hefty legal bill to defend the claim. Penalties could also include a prison sentence.

Many dog owners have pet insurance which gives public liability cover. If you don't have pet insurance but you have home insurance or rental insurance, it may include third party public liability insurance; it is worth checking the small print. If you don't have any third party public liability insurance, it is worth exploring available policies.

It may save you a fortune.
