



## Kithill Planning Application

The outline planning application for up to 150 residential dwellings at Kithill was recommended for refusal by the Town Council and the application was indeed refused by SSDC, who are the Planning Authority. Unfortunately, the developer submitted an appeal which the planning inspector subsequently upheld.

The Town Council sought the advice of a specialist barrister, who confirmed that the appeal was correct in law and there would not have been a case for a judicial review. There was, however, a point that the inspector had included in his report that specified that certain works were required to be completed on the site, before development could begin. This was the stopping up of the pedestrian crossing and diversion of the footpath away from the railway line. The barrister pointed out that, if residents and community groups raised a sufficient number of objections to the diversion of the footpath with Network Rail and with the County Council Rights of Way Officer, then there would need to be an enquiry which would almost certainly delay the commencement of the development. ## REORGANISATION Crewkerne and Ilminster Schools

Proposals drawn up by Somerset County Council to change from the current 3-tier system school system to a 2-tier system, would have a dramatic effect on the schools in the Crewkerne and Ilminster area. These proposals, which are now in a period of consultation, have been considered by Crewkerne Town Council.

Councillors were agreed that the current proposals would not be in the best long-term interests of Crewkerne and the surrounding villages. They were concerned that the proposals focussed on short term issues of pupil numbers and did not take into account the major housing developments in the pipeline for Crewkerne, which would see a large increase in the number of families living in the Crewkerne area. Councillors were also concerned that the proposals would result in the senior schools being saved at the expense of the junior schools and that the timing of this proposal was not appropriate, as it had come at a time when the whole future of local government in Somerset was under review.

The Town Council agreed to write to the County Council, expressing their severe concerns over the current proposals.

## The Future of Local Government in Somerset

Somerset currently has a traditional 3-tier system of local government, with Somerset County Council, four district councils and of course the town and parish councils like Crewkerne Town Council, as the lowest tier of local government. But this system of local government is proving increasingly unsustainable as budgets come under increasing pressure and the cost of delivering services mounts. Reform is urgently needed and there are two different proposals on the table for a restructured local government framework in Somerset. The first is from Somerset County Council and is known as **One Somerset**. The other is from the four district councils and is known as **Stronger Somerset**.

- **One Somerset** would see the county council and four district councils replaced with a single new council.
- **Stronger Somerset** would see the county council and four district councils replaced with two new councils, dividing the county into East and West regions.

Full details of the **One Somerset** proposal can be found on the Somerset County Council website, and similarly the details of the **Stronger Somerset** proposal can be found on the SSDC website. Both Somerset County Council and SSDC are inviting feedback from residents.

The members of Crewkerne Town Council debated the two proposals at a recent Council meeting. The Town Council agreed that the **Stronger Somerset** proposal offered the best opportunity to ensure that local government in Somerset was sustainable into the future and offered the best opportunities for those growing up, living, working and being cared for in the communities of Somerset. On that basis, the Town Council agreed to put its full support behind the **Stronger Somerset** proposal.

## Sadness at death of a former Councillor

The Mayor and fellow Councillors offer their condolences to Teresa Bond on the sad death of former Councillor Ron Bond who died recently.

Ron was elected as a Town Councillor in 2008 and served for over 4 years. In addition to this Ron worked tirelessly within the town, mainly as the chairman of Crewkerne Hospital League of Friends, during his time on the committee he oversaw the refurbishment of the physio department and Penny's Garden.

## George Reynolds Centre: AN UPDATE

As reported in the previous edition of this newsletter, the charity responsible for managing the GRC community centre regrettably ceased operations earlier this year, with responsibility for the building reverting back to the Town Council.



Since then, the Council has been working hard to address a number of significant maintenance issues identified with the building to ensure that, when the doors do re-open, the building will be fully fit for purpose. Good progress has been made, which has at least allowed the Jigsaw pre-school group to continue to operate at the centre. In addition, repair works are planned imminently, which will allow the Active Learning & Skills youth group to re-establish operations in the building. Both of these childcare groups have put in place the necessary covid secure procedures to ensure safe operation.

Looking forward to a time when the GRC can be fully re-opened as a centre supporting local community groups, sports clubs and social and business events, it is clear that this will depend on when coronavirus restrictions are lifted to allow this. Realistically, this is very unlikely to happen before the spring of next year. But the Council plans to make good use of this time, to put in place further improvements to the building to enhance its appearance both externally and internally, and to plan how best to manage and promote the centre, to ensure that it is an asset to the community going forwards.



## QUEEN'S BIRTHDAY HONOUR for a former Town Councillor

Former Town and District Councillor Angie Singleton has been awarded an MBE in the Queen's Birthday Honours for services to Community Health and Wellbeing.

Angie served as a Town Council for over 20 years and as a District Councillor for 11 years. During her time as a Town Councillor, Angie played a leading role in many activities and projects, but most notably she was a leading light in bringing to fruition two major town centre community building projects, namely the George Reynolds Centre and the Crewkerne Aqua Centre. Angie has been and remains a very active member of the local community, with her involvement in the management of the GRC, the Aqua Centre and her membership of various community groups such as ABCD and the Christmas Committee, to name just two.

Angie's drive, commitment, and good old common sense, made her an outstanding Councillor, liked and respected by her fellow Councillors and the Council staff. Angie's award of the MBE is richly deserved.
