After discussion of the third draft of the budget tabled by the Clerk and Finance Officer, it was **AGREED to recommend to Full Town Council the draft budget and associated precept calculations for 2019/20.**

Councillors noted that the budget did not contain an allowance this year for an apprentice. Cllr. Mrs Head explained that, with the forthcoming move to the new workshop, a period of time was required to allow the new Amenities Operations Manager and the grounds staff to "bed in" and terms of evolving their working practices to take account of the new accommodation arrangements. It was therefore sensible to defer consideration of employing an apprentice until this bedding-in process was complete, which would reasonably expect to take around 12 months.

29 CONSOLIDATION OF BURIAL COMMITTEE ACCOUNTS

The Clerk's report and recommendations were noted. Cllr. Best made the point that the Council should avoid the situation where money was transferred to West Crewkerne Parish Council at the end of this financial year, only for the Parish Council to be invoiced immediately afterwards. He also stressed that the funds transferred to the CTC bank account should be ring-fenced.
