He also reported that the Devon & Somerset Fire & Rescue Service were in the process of replacing some of their existing fire tenders with Rapid Intervention Vehicles (RIV's).

The Clerk reported that Cllr. Mrs Singleton had verified the accounts for March 2019 in accordance with the Council's Financial Regulations and Risk Management.

# Accounts for payment in the sum of £26,731.71 + VAT for March 2019 were APPROVED.

b) <u>To report the bank reconciliation for February 2019 has been completed</u>

The Clerk reported that Cllr. Mrs Singleton had verified the bank reconciliation for February 2019. It was noted that cash in hand as of 28 February 2019 was £252,855.87.

c) <u>Crewkerne Sports and Youth Activities Ltd (CSYAL) debt: to consider how to</u> proceed regarding the CSYAL debt

The Clerk's report on the outstanding CSYAL debt was noted. The Clerk added that the District Valuer had proposed an initial level of rent prior to the opening of the GRC, with the recommendation that this rent be re-evaluated once the building was established in operation, to reflect the actual net income generated. Cllr. Hodgson pointed out that, with hindsight, an earlier recognition of the marginal status of CSYAL's finances might have allowed the rent to have been adjusted earlier. He also stated that writing off the debt did not preclude the Council from increasing the rent in future, when CSYAL's financial situation would hopefully improve.

Cllr. Miss Pritchard proposed that CSYAL should be asked to pay off the debt gradually over a period of time. Cllr. Mrs Head seconded this proposal. Votes for the proposal: 3 Votes against the proposal: 4 Proposal not carried.

Cllr. Hodgson proposed that the CSYAL debt be written off. Cllr. Mrs Stuart seconded this proposal. Votes for the proposal: 4 Votes against the proposal: 3

It was therefore AGREED that the CSYAL debt be written off.

#### d) <u>Audit of Internal Controls: to note the result of the annual audit of internal controls</u>

The report was noted.

e) <u>Risk register: to review the Financial Risk Register</u>

Councillors reviewed the draft update to the Financial Risk Register. After discussion, it **AGREED to approve the updated Financial Risk Register, with the minor amendments noted in the meeting**.
