#### TOWN AND COUNTRY PLANNING ACT 1990 APPEAL BY: Mrs Heather Palmer SITE AT: 64 Middle Path, Crewkerne, Somerset TA18 8BG APPEAL START DATE: 19<sup>th</sup> October 2022 APPEAL REF: APP/R3325/C/22/3308600

An Enforcement Appeal has been lodged in respect of the above. It is to be decided on the basis of Written Representation and a site visit by an Inspector appointed by the Secretary of State.

#### A description of the alleged breach of control is:

Without planning permission, the erection of garden building in the form of a summer house (oriental style).

#### The Council issued the Enforcement Notice because:

It appears to the Council that the breach of planning control mentioned at paragraph 3 above has occurred within the last 4 years.

The land consists of a single storey dwelling house with a garden situated in a residential area located adjacent to the Crewkerne Conservation Area in an area characterised by a mixture of properties set in their own grounds. It is considered that the summer house has an overbearing relationship with the neighbouring property due to its height and size would harm the living conditions of the neighbouring residents and would be at conflict with the development plan as a whole and also by reason of its size, scale, and the material used, does not respect the character of the area and causes demonstrable harm to the residential amenity in accordance with the aims and objectives of Policy EQ2 of the South Somerset Local Plan (2006/28) and the provisions of the National Planning Policy Framework (2019).

The Council do not consider that planning permission should be given, because planning conditions could not overcome the latter objections to the development.

## The appellant has appealed against the Enforcement Notice on the following grounds:

(a) that, in respect of any breach of planning control which may be consulted by the matters stated in the notice, planning permission ought to be granted or, as the case may be, the condition or limitation concerned ought to be discharged;

- (c) that those matters (if they occurred) do not constitute a breach of planning control;
- (d) that, at the date when the notice was issued, no enforcement action could be taken in respect of any breach of planning control which may be constituted by those matters;
- (e) that copies of the enforcement notice were note served as required by section 172;
- (f) that the steps required by the notice to be taken, or the activities required by the notice to cease, exceed what is necessary to remedy any breach of planning control which may be constituted by those matters or, as the case may be, to remedy any injury to amenity which has been caused by any such breach;

If you send your representations after the deadline they will not normally be seen by the Inspector and may be returned. 

# West of England (Exeter-Salisbury) Rail Line: Strategic Outline Business Case Letter of Support

In recent months, Devon County Council (DCC) has funded the production of a Strategic Outline Business Case (SOBC) for upgrading the West of England railway line, which connects Exeter to Salisbury, Basingstoke and London Waterloo. The upgrades would enable a half-hourly service between Exeter, Cranbrook, Honiton and Axminster, and improve the reliability of all West of England line services.

The purpose of the SOBC is to set out the rationale for investment and provide enough evidence to Government for the scheme to proceed to the next stage of development. My reason for contacting you is to ask if you will provide a letter of support for submission with the SOBC, to help demonstrate the importance of the upgrades to communities and businesses across the South West.

As detailed in the SOBC, the proposals comprise the construction of an additional passing loop between Cranbrook and Whimple, possibly encompassing one or both stations, and the extension of the existing Honiton loop westwards. This is illustrated in the schematic diagram below:



At present, over 75% of the Exeter-Salisbury line is single track, meaning a delay to one train can cause escalating delays to subsequent services. This unreliability causes inconvenience to commuters, students and leisure travellers, and makes rail



less attractive to those with access to a car. The infrastructure also makes it infeasible to improve the typical service frequency above 1 train per hour.

The proposed scheme would help address these issues by providing the network with additional flexibility, increasing opportunities to recover time and reducing the need to terminate services prematurely. This would benefit communities along the entirety of the line, as delays between Exeter and Honiton can, for example, impact passengers travelling from Crewkerne or Sherborne to Salisbury. It would also enable a doubling of the service frequency between Exeter and Axminster, helping alleviate overcrowding at peak times and improving connections with other rail and bus services.

These upgrades would increase the accessibility of villages, towns and cities along the West of England line, enabling businesses to attract more customers and recruit more employees. The proposals would help unlock planned growth at Cranbrook, Honiton and Axminster, and would increase the rail network's resilience to closures on the Great Western mainline. Following the closure of various branch lines in the 1960s, the line serves a much wider catchment, and hence the scheme could also benefit residents of towns such as Sidmouth, Lyme Regis and Chard.

With the line serving four Areas of Outstanding Natural Beauty (East Devon, Blackdown Hills, Dorset and Cranborne Chase & West Wiltshire Downs) and the Jurassic Coast World Heritage Site, the scheme could deliver a significant boost to the South West's tourist industry. The ability of DCC, train operators and Network Rail to deliver such growth in partnership is proven by the success of the reopened Dartmoor Line, where patronage has significantly exceeded forecasts, boosted by DCC-funded bus links from Okehampton station.

Finally, by providing a more attractive alternative to the car, the proposals would help reduce congestion on the local and strategic road networks and reduce pressures on parking capacity. As such, it is aligned with local authorities' and central government's commitments to tackle the Climate Emergency and deliver Net Zero carbon.

In summary, the scheme would support economic growth across Devon, Dorset, Somerset and Wiltshire, would improve access to opportunities for those without access to a car, and would help reduce congestion, pollution and greenhouse gas emissions.

We are aiming to submit our business case later this year and so would be grateful of a letter of support **before the end of November 2022.**

<u>Agenda Item 10:</u> to note correspondence received regarding parking issues in Scutchings Lane and consider writing a letter in support of Ashlands Primary School to Stonewater

#### **Background:**

Crewkerne Town Council has been copied into correspondence regarding dangerous parking on Scutchings Lane. As this is unadopted highway, the school has been told that complaints should be made directly to Stonewater. The original correspondence is copied below.

#### **Recommendation:**

Councillors to decide if they wish to write in support of Ashlands Primary School to Stonewater.

*"I would like to make a serious complaint about the new road leading down to the newly built Ashlands C Of E Primary School Parent Car Park in Crewkerne.* 

As the road currently is, it is a danger to children and parents and those trying to drive along it due to the lack of double yellow lines. This enables parents who are too indolent to walk up the hill from the car park to the school to park along the road causing major access issues as well as risk of life to children running out into the road to cross.

Cars park along the whole of the road down to the car park and this means the road becomes single traffic only, if a car is trying to come down the road to the car park (or the housing estate) while a string of cars are trying to come up to leave, then there is nowhere safely for either set of cars to go - they either have to reverse out on to a busy North Street, mount the whole pavement full of children and parents trying to walk safely to school, or they have to reverse in a chain down the hill until there is space to let the approaching car pass. It is dangerous, it is panic inducing and it is totally unacceptable!

Myself and a number of other parents at the school have been part of or witnessed how difficult and unsafe this situation is and something needs to be done as a **matter of urgency** - even if it is just cones along the whole road initially until a more permanent solution can be found.

It is no fault of the school as they have sent many letters and reminders out to parents asking them not to park along that stretch of road but unfortunately because it is currently legal to do so people without consideration for others safety still do it.

Please address this matter urgently."
