OPEN FORUM

A resident expressed her disappointment that the tennis courts were still closed to the public. She noted that they had been closed since 2019 and refurbishment dates were continually changed. She asked the following:

- Why had the War Memorial Commemoration Trust and Crewkerne Town Council passed the refurbishment to South Somerset District Council and the Lawn Tennis Association?
- At the last meeting of the Amenities Committee of Crewkerne Town Council it was agreed that the cost would be £1 per session. Could the Trust or the Town Council confirm how long a session would be?
- Tennis Courts in Merriott and Ilminster were available to play on free of charge. Could the Crewkerne courts also be free to use?

The Trustees agreed to forward the questions to the next meeting of the Amenities Committee of Crewkerne Town Council, to be held in May.
