- The graffiti wall art project would hopefully be delivered in either the Easter holidays or May half term in conjunction with the Council's Youth Service.
- The new accessible roundabout had been installed and was now operational.
- A funding application for the spring riders had been submitted.

Councillors noted that allotment inspections were due and that once the Deputy Clerk appointment process had been completed, this would be implemented again.

Cllr. Best noted that the Aquacentre's drain down was now scheduled for 2024.

# 37 TENNIS COURTS

# 22/23 To receive an update on the planned courts refurbishment at Severalls

The Town Clerk reported that she had met with the LTA project lead the previous week. The appointed contractors had visited all 12 courts included in the district-wide project prior to Christmas to price up the works against the surveyor's report. It had been ascertained that costs had risen due to inflation and the revised quotes were submitted to the LTA board for approval. The next step would be for South Somerset District Council to sign the contract to move the works forward. There



would need to be site meetings to talk about access and clearance works where vegetation overhanging courts (more relevant to other sites than Crewkerne).

# 38 BINCOMBE BEECHES

22/23 <u>To consider a proposal for compensatory tree planting of 100 donated trees or donation to earmarked tree planting fund</u>

Councillors discussed the proposal, and while generally supportive of the principle of increasing tree stock in the town's open spaces, felt that they would be more comfortable accepting offers of saplings or donations following the due process carried out with these applications by SSDC as the Local Planning Authority and the Tree Officer.
