Minutes of a meeting of the Joint Burial Committee held on Monday 3rd April 2023 at 18.45 in the Council Chamber, Town Hall, Market Square Crewkerne.

OPEN FORUM:

Members of the public raised the following issues:

- Lime trees on the cemetery border had been identified by Taylor Wimpey for removal as part of their northern site reserved matters application. He asked whether the Council could investigate whether these trees were in fact council-owned, as they appeared to be inside the cemetery boundary.
- The second chapel had originally had pews and hand sewn tapestries and it was asked if there was any information on their current whereabouts.

Cllr. Best responded that the Clerk would investigate the matters of cemetery boundaries and tree ownership further. If Councillors formed the opinion that the trees were in fact council-owned, the Clerk would be formally asked to write to Taylor Wimpey stating this. He also recalled that in over thirty years he had not known the second chapel either used for services or to have pews/tapestries but asked the Clerk to investigate further.
