195 APOLOGIES FOR ABSENCE

The minutes of the Town Council meeting held on 27 March 2023 were AGREED as a true and accurate record.

198 TO RECEIVE REPORTS FROM THE UNITARY COUNCILLORS

22/23

Cllrs. Ashton and Best reported that:

- Unitary Councillors were continuing with planning training for the new Area South Planning Committee.
- The new planning system would see an increase in applications delegated for officer decisions and Parish and Town Councils would now have 21 days to call an application into the Committee.
- Local Community Networks (LCNs) would start meeting in June or July.
- A number of meetings had taken place regarding the proposed reorganisation of stroke services in Somerset, with both Councillors highlighting their concerns over the removal of acute hospital-based stroke services from Yeovil District Hospital.

199 CLERKS PROGRESS REPORT

The Town Clerk reported that:

- Somerset Council had confirmed a Play Day to be held in Crewkerne on 2 August 2023.
- The planned works to ash trees at Bincombe Beeches had been scheduled for the end of May, with replanting events to follow in October.

The Deputy Clerk reported plans were progressing for The Big Picnic in the Park on Sunday 7th May at 12:00 until 16:30 at Henhayes, noting that:

- Volunteers for setting up and clearing up plus other tasks would be warmly welcomed.
- Various groups, stalls and activities were now confirmed.
- Flags would go up on Sunday 30 April, with thanks to Rotary for their assistance.
- An information board showcasing various voluntary organisations in the town would be put together.

Following receipt of confirmation from Somerset Council that they would fund and run one play day in Crewkerne over the summer holidays, Councillors AGREED to fund one additional play day via the Youth Service provider, ALS, at a cost of £600.
