64 TO CONFIRM THE MINUTES OF THE MEETING HELD ON 13 FEBRUARY 2024

66 OPEN FORUM

23/24

No members of the public were in attendance.

67 CLERK'S PROGRESS REPORT

23/24

The Clerk reported that the spitfire memorial sign had arrived and the Shed was making a frame and stand for it. The Shed was also making a wooden map of the war graves.

Some discussion took place about anticipated works to the Chapel and Lodge later in the year. Councillors felt that with this in mind it would be better to delay the Open Day to 2025 to avoid issues with access/scaffolding etc.

23/24 To consider how to mark these events

Councillors noted that the request to the War Graves Commission to have the war graves cleaned had been agreed. The Clerk was asked to contact the RBL to enquire if this could be carried out before 6th June.

Councillors agreed that they would like to leave a lamp of peace in the chapel doorway to commemorate the 80th anniversary of D-Day. It was hoped that an official unveiling of the spitfire plaque could be arranged for Sunday 9th June, with representatives of the pilot's family to be invited to attend.

70 CEMETERY PATH WALLS

23/24 To consider quotes for repairs to the footpath wall

It was AGREED to award the contract to Luke Grafton Stonemason Ltd for the total of £2,482 and to delegate all arrangements for the works to the Operations Manager.
