68 TO RECEIVE THE UPDATED ACTION STATUS REPORT 23/24

Cllr. Ashton advised that Somerset Council still have money in earmarked reserves for the development of the Millers Garage site.

The speeding of cars around Gouldsbrook Terrace/Church Street was agreed to be removed from the Action Status Report. Councillors were reminded to report any speeding matters to the Police.

The wall adjacent to Gouldsbrook Terrace has been discussed with Highways and there is nothing more they can do. The homeowner is not responding to letters.

Cllr. Samuel reported faded road markings at the junction of Wynnstay/North Street – Deputy Clerk to report to Highways.

There was also discussion over many loose paving slabs in different areas throughout the town. The Clerk advised Councillors to take photographs and then we can report to Highways.

The church steps are still awaiting repair. The Deputy Clerk will keep chasing this matter. There were several loose slabs on the approach to the church steps, but this now seems to have been repaired. Perhaps this was done by a member of the public?

TO CONSIDER A REQUEST FOR BETTER LITTER AND DOG BIN PROVISIONS IN THE KITHILL AREA 23/24

Since writing the agenda, Somerset Council have installed a new co-mingle bin.

TRAFFIC SURVEY - TO NOTE THE RESPONSE FROM SOMERSET COUNCIL 23/24

Somerset Council won't consider a new traffic survey until the link road has been built. ABCD wanted to move the bus stop away from the Kings Arms. The Town Clerk/Deputy Clerk to check if having the survey was a condition of moving the bus stop. There was discussion over whether having the bus stop after the traffic lights would be a safe place, especially due to the three diverging roads at the end of Market Street. When the bollard was outside Gresham Books it was considered potentially hazardous for buses pulling out, but now the bollard has been removed. The current set up is not adequate, particularly in the winter.

The Town Clerk to enquire whether Cllr. Best has had any response from the bus companies.
