The Council strongly supports CPRE's position which continues to object to the application and trusts these concerns will be considered during the appeal process.

082 TO CONSIDER THE INSTALLATION OF THREE NEW GRIT BINS

Cllr. Draycott left the room.

Councillors discussed the following points:

- Kithill A grit bin here would be a welcome addition for the residents.
- Thomson Drive Councillor Best is in discussions with Highways over the most suitable location.
- Beechwood Drive This road is unadopted so Crewkerne Town Council would be responsible for filling it.
- Somerset Council will fill grit bins initially at the start of the season and then will fill as resources allow and contractors are available.
- Cllr. Woodland reported that the Furland Road bin is empty.

It was agreed to install the three bins and delegate the arrangements to the Deputy Clerk and Operations Manager.

Cllr. Draycott returned to the meeting.

083 TO RECEIVE THE UPDATED ACTION STATUS REPORT

- Miller's Garage Councillors noted that the public consultation on the forthcoming planning application at Cropmead Orchard was well attended.
- Gouldsbrook Terrace The wall has deteriorated further; however, it is under private ownership.
- Diseased tree on Market Street Councillors discussed whether plans for a one-way system may impact newly planted trees and whether it would be best to delay any planting. It was noted that the £300 licence can cover multiple trees.

084 TO RECEIVE A REPORT FROM THE NEIGHBOURHOOD PLAN STEERING GROUP

The Clerk reported that they are in the process of combining drafts into one skeleton draft. Surveys will be going out to employers, town centre businesses and Wool Gardens residents as those groups were unrepresented in the initial survey.

Discussion then took place around some matters of report:

- Councillors discussed blocked drains on Severalls Park Avenue. These have been reported to Somerset Council but not deemed bad enough to fix. There was a question raised over whether the Grounds Staff had been asked to monitor these drains. Councillors had no recollection of this and had concerns that if this were to happen it would set a precedent for other areas in the town. Concerns were also raised that the Grounds Staff would not be insured to carry out any works to the Highway.
- The new sink in the public toilets has been installed. The Police are investigating the incident, and an insurance claim has been filed. There was discussion over whether there should be CCTV in the area and if that would be the responsibility of the Falkland Square management company. The Police have confirmed that even if there was CCTV they would need evidence that the sink was undamaged before the perpetrator entered the toilets.



• Parking in Brickyard Lane/Tannery Court – No response has been received following a letter to Ashlands Primary School.
