The Old Bakery Bincombe Lane Crewkerne Somerset TA18 7LY

Notification of intent to Fell No. 1 Tree and carry out Tree surgery works to No. 2 Trees within a Conservation Area.

- 1) Remove ONE ASH tree which has ASH DIEBACK and is dead. Tree approx.
- 30 feet tall. Spruce tree already planted (6 foot tall) to fill the gap.
- 2) Pollard several branches of second ASH which so far remains largely healthy.
- 3) Pollard ONE MAPLE at crown has squirrel damage and is dead. Remove approx. 15 foot of tree and pollard/shape remainder of the healthy tree.
