- The Deputy Clerk was asked to provide an update for each item ahead of the next meeting
- Councillors expressed their frustration at the ongoing lack of progress with the Miller's Garage site and requested that the Deputy Clerk write to the Planning Officer and Adam Dance MP to urgently seek a clear update and a definitive timeline for the provision of the car park. Councillors also believe that the funding for this project remains ring-fenced and wish to see it used for its intended purpose without further delay.
- There was discussion around the diseased tree on Market Street. It has been reported as dangerous several times to Somerset Council but no progress has been made.
- The wall at Gouldsbrook Terrace has deteriorated further but it is under private ownership.
- The Deputy Clerk will enquire whether the faded zebra crossing will be repainted as part of the Waitrose refurbishment. The Deputy Clerk will report the faded lines at the junction of North Street/Wynnstay.
- Two grit bins are awaiting installation at Beechwood Drive and Kithill. Cllr. Best is awaiting approval from Highways for the location of the third bin on Thomson Drive.
