25/26 <u>To consider applications requiring comment before the next Planning and Highways Committee</u> meeting:

a) 25/01865/TCA 5 Lyme Road Crewkerne Somerset TA18 8HE Notification of intent to carry out tree surgery works within a Conservation Area to No. 1 Conifer (T1) topping required to prevent contact with overhead power lines, No. 1 Hazel (T2) topping to prevent contact with telephone wires, No. 1 Damson (T3) trimming of branches overhanging pond and No. 1 Leylandii (T4) topping and thinning to prevent storm damage and contact with guttering.

Councillors made no comments on this application.

b) 25/01844/HOU 10 South Street Crewkerne Somerset TA18 8DA

Change of colour of masonry from cream to white, change window and door colour from white to grey, replacement of existing rooflights, re felt and batten and chimney repairs. New doors to rear elevation, formation of balcony on top of existing flat roof with screening around.

Councillors noted that the property is not a listed building and that preapplication advice indicated no consent was required. Concern was expressed that the proposed balcony may overlook adjacent properties and cause disturbance to neighbours.

It was AGREED to support this application with comments submitted to this effect.

Councillors also drew attention to a privately owned wall at the junction of Barn Street and Lyewater which has been damaged for a second time. It was requested that the Clerk pass this information to Highways to explore possible solutions.
